Sadowski & M. Horsley on what was proposed at the September 14, 33 2017 work session. More discussion will be held during the next few months. 34 35 2018 BUDGET DISCUSSION: Chairman White stated that our preliminary budget needs to be submitted to the Selectmen's office by 36 37 Monday, October 2, 2017. He stated that he is proposing to create a training budget line and transfer \$1000 from the Consulting line thus decreasing the Consulting line item from \$8500 to \$7500. There 38 would be no net increase in our budget. He stated that the Town Administrator has confirmed that 39 40 they could create a new line item for training.
