Review and discuss letter from resident, Glenn Woodward, regarding stockpiling of snow on Main Street

The Board reviewed Mr. Woodward's letter regarding his complaint that the stockpiling of snow on Main Street is causing a prolonged mud season on the property his multi-family home is on. The Board would like the Town Administrator to respond to Mr. Woodward's letter letting him know that they thought the thrust of the January 8th meeting with him was his interest in purchasing that lot. They will have the Town Administrator speak to the Road Agent about moving the stock pile off that property.

Review and discuss email regarding proposed legislative changes to the Right To Know Law.

The Town Administrator made the Board aware of legislation that would require the Board to publish an agenda 72 hours prior to the meeting. Since the Town's meeting is on Wednesdays, this would require our agenda to be posted on Friday. Unfortunately, that would mean that no further business could be added between Friday and

Wednesday so it could prolong the time that the Board could take up a matter. In addition, it can be presumed that the Board could not take up any walk-in matters at a meeting.

Mr. Lambert would like to declare William Broughton the winner of a write-in vote for Trustee of Trust Funds, for the three year position, with 9 votes. Mr. Lambert is not going to declare a winner for the one year position for Trustee of Trust Funds because there were several people with one vote and one person with two votes.

Chairperson Bergeron made a motion, after reviewing the moderator's email outlining his intentions, to support the Moderator's position. Selectman Reardon seconded.
