The position will start after Thanksgiving and will be conditioned on pending reference checks and satisfactory criminal and motor vehicle reference checks. Selectman Blease seconded. Vote: 2-0.

6:00 p.m. Meet with George McCreery re: complaint about vehicle inspections

The Board met with Mr. McCreery about his complaint regarding the BOS having vehicle inspections done by a new vendor. Selectperson O'Keefe read a prepared statement. Mr. McCreery feels that the Selectmen sent the message that no vendor in this town is capable of doing qualified inspections. Selectperson O'Keefe is not saying that. They wanted a one-time independent, consistent documentation of an inspection. Mr. McCreery says it hurts that they are not trusted and that is a lot of money there and it would have been nice if it had been spent in town. Selectperson O'Keefe says that money was spent on repairs on vehicles that are inspected twice a year. Someone asked if this included any servicing. The Board provided Mr.

McCreery with copies of the invoices for the highway and fire department inspections. This Board will not compromise safety. Mr. McCreery asked the Board if there is an expectation, in the future, of documentation that will be filled out by the service station to document inspection repairs. The parties agreed that there should be some kind of checklist that goes with the vehicle.

Board authorized Fieldstone to do the drainage calculation and authorized \$600.

#### Review, discuss and approve road side mowing

Selectperson O'Keefe and Road Agent Mike Bergeron discussed mowing bids. Mr. Case withdrew his proposal he doesn't currently have the equipment to do the mowing. Selectperson O'Keefe made a motion to award mowing to Scott Blease with a price not to exceed \$1900. (Selectman Blease recused himself) Selectperson O'Keefe asked the Town Administrator to contact Selectperson Bergeron tomorrow and get her opinion of this, since Mr. Blease cannot vote.

#### Review and discuss options for High Street slope stabilization

The Board reviewed Concept 2A which they had requested the Town Administrator obtain from Headwaters Hydrology. This would include leaving the sheet pile wall in place and starting the project with phase 1 prior to the ground freezing this winter. The Board decided the next step is to see if FEMA would be open to the \$1.43 million Concept 2A project.

The Board would like the Town Administrator to turn this matter over to their attorney.
