Pilgrim Foods came to the WWTF at about 3 p.m. on Tuesday, March 2, 2010 requested that they be allowed to give the Treatment Facility more flow. The flow they are requesting would violate both their old permit and the new permit. Carla noted that they had to go into high flow operations. Our solids are high right now. If we take additional flow it will give more food and the bugs will grow too fast.

Carla will get with Kelley tomorrow make sure we have all docs. Those will be sent to Attorney Sargent. The Town Administrator will call Atty. Sargent and provide him with Carla's contact info and follow up with timeline.

The Board reviewed the reports as submitted by the Welfare Director/Town Administrator.


**Bankruptcy claim for FairPoint**


**Adjournment**
