It was noted that members should use safety cones and signs during clean up. Email group members about when you plan to go out. All flower beds should be cleaned up before May 18th so mulching can begin.

Jim will call Tom Plourde about street sweeper.

Town clean up (managed by the Conservation Committee) will be on May 29th. Those participating should meet at the Town Hall at 9am. It was noted that the Lions were cleaning up the week before.

Open discussion about littering. Committee agreed to start an Awareness Campaign. Kits will be made available at the Rabies Clinic, in the annual dog license mailing, and at the Town Hall and Post Office. Deb W will get info on signs.

Open discussion about demolition of abandoned building on Main St. Funds will be needed for rehab. The Community Profile will outline all open spaces/parks belonging to the Town that require maintenance/upkeep. Deb S will petition Town for funds.

Deb S will attend the May 10th Selectman's meeting to discuss placement of tree (which needs to get planted asap).

Jim Lambert who will find out who owns property at the chain link/bamboo plot near elderly housing to see if we can continue clean up. He will also inquire about replacing the guard rails at the corner of Mill St and Hubbard Hill (near brook)
