The Greenville Board of Selectmen met on **Wednesday, August 9, 2023** in the Town Hall, 46 Main Street, Greenville, NH 03048.

In attendance were Chairperson Carla Mary, Selectman Douglas Reardon, Selectwoman Maggie Bickford, and Administrative Assistant Kelly Fitzwater

Chairperson Carla Mary called the meeting to order at 3:30 pm.

Firefighters Association

Discussion was had about the Firefighters Association using only the Fire Station meeting room.

Motion to approve the use of the meeting room only at the Fire Station by the by the Firefighters Association by Selectman Reardon, 2nd by Chairperson Mary. Motion carried with 3 in favor, none opposed.

Greenville Firefighters Foundation, Old Home Day Application: Food Vending

Discussion was had about the Firefighters Association selling hamburgers and hotdogs at Old Home Day. It was relayed by Kelly Fitzwater, that because this the Town's event, the Town would be covered by the Town's insurance.

Motion to approve the Greenville Firefighters Foundation to sell hamburgers and hotdogs at Old Home Day on August 26, 2023 by Chairperson Mary, 2nd by Selectwoman Bickford. Motion carried with 3 in favor, none opposed.

Request to use Meeting Room: Brookline/Mason/Greenville Republican Party

Fred Floreth of 1 Temple Street, came before the Board for use of the Greenville Town Hall Meeting Room on Wednesday, September 13, 2023, from 7:00PM to 8:00PM for the purpose of their Committee's monthly meeting. The Board discussed the policy and if the \$25.00 per hour fee set forth in the Town's Policy would be required. Discussion was had about the fee and if the Committee was considered a non-profit.

Motion to approve the use of the Greenville Town Hall Meeting Room on Wednesday, September 13, 2023, from 7:00PM to 8:00PM for the purpose of their Committee's monthly meeting, and waiving the \$25.00 fee by Selectman Reardon, 2nd by Chairperson Mary. Motion carried with 3 in favor, and none opposed.

Motion to a accept the donations of \$3,2500.00 and \$2,821.13 to Defender Fire by Selectman Reardon, 2nd by Chairperson Mary. Motion carried with 3 in favor, and none opposed.

Nathan Jones Water/Sewer Service Application

The Board discussed the connection service for Nathan Jones and if it was possible to connect to services.

Chairman Mary expressed that the Water/Sewer Department should be the ones to see if it's possible to connect to Sewer and Water, but did not for see an issue with approval, with the Board members in agreement.

YTD Budget Reports; General Fund, Water, Sewer

The Board discussed the budgets for July 2023 and had questions on a couple budget lines. Ms. Fitzwater stated that she would look into the accounts in question.


