ORDINANCE
NUMBER 92-01A

PARKING CONTROL

1. Authority

This ordinance is by order of the Board of Selectmen of the Town of Greenville, New Hampshire in accordance with RSA 41:11.

2. Purpose

The purpose of this Ordinance is to:

- a. Provide increased safety and protection to motorists, pedestrians and others using the public ways in Greenville NH.
- b. Reduce the danger to the Town and State service operations and personnel in plowing, repairing, and maintaining Town/State roads and property.
- c. Prevent physical and environmental damage to Town roads and property.
- d. Protect the quiet and safe enjoyment of both private and public property by all who visit or live in Greenville.
- e. Provide an ordinance that can be enforced by local police officials.

3. Definitions

Commercial vehicle: A motor vehicle or trailer that exhibits one or more of the following characteristics:

- a. Has more than two (2) axles;
- b. Has a height greater than seven (7) feet;
- c. Has a weight greater than eleven thousand five hundred (11,500) pounds gross vehicle weight rating (GVWR);
- d. Is registered as other than "passenger", "antique" or "street rod" vehicle, and is designed, maintained or used primarily for the transportation of passengers, property or freight for hire, compensation or profit; or
- e. Has special ramps, hoists, hooks, buckets, cranes, arms, platforms or similar features designed primarily to lift, tow or carry motor vehicles, equipment, trailers, materials or workers.

A commercial vehicle does not include a vehicle that is modified to accommodate an operator or passenger with a disability, a recreational vehicle or recreational equipment, and which is for personal use only or a vehicle used exclusively for agriculture or farming when located on and accessory to a permitted agricultural use,

Vehicle: Every device in, upon or by which any person or property is or may be transported or drawn upon a highway (to include all manner of non-motorized trailers).

4. Regulations

Section A. General Restrictions

Parking on all public ways in the Town of Greenville will be controlled as follows: except when necessary to avoid conflict with other traffic, or in compliance with law or the direction of a law

enforcement office or official traffic control device no person except a operator of an emergency vehicle or official town or state vehicle shall stop, stand or park a vehicle:

1. On the roadway side of any vehicle stopped or parked at the edge or curb of a street;
2. On a sidewalk;
3. Within an intersection;
4. On a crosswalk;
5. Upon any bridge or other elevated structure upon a public way;
6. At any place where official signs prohibit stopping, standing or parking;
7. In front of a public or private driveway;
8. Within 15 feet of a fire hydrant
9. Within 20 feet of a crosswalk at an intersection;
10. Within 30 feet upon the approach to any flashing signal or stop sign located at the side of the roadway;
11. Between the yellow center line and the white shoulder line on any roadway so marked;
12. Any curb area marked with yellow paint;
13. In any area marked for "Police Vehicles Only";
14. In any area marked for "Police Visitors Only" or "Police Business Only";
15. With left wheel (driver side) to the curb or side of roadway;
16. Outside of marked lines at designated parking spaces;
17. No parking in the lot on west side of fire station.

Section B. Prohibitions

1. A person shall not park a vehicle upon any street, highway or public parking facility for the principal purpose of:
 - a. Displaying it for sale or displaying advertising.
 - b. Washing, greasing, performing maintenance or repairing such vehicle except repairs of an emergency nature.
2. A person shall not, on a public way:
 - a. Leave an unattended vehicle idling for any period of time unless the operator is using a lawfully installed remote start device.
 - b. Leave a vehicle parked for a period of time exceeding forty-eight (48) consecutive hours unless otherwise specifically authorized by the Chief of Police or his designee.
 - c. Park a commercial vehicle, recreational vehicle, or recreational equipment for a period exceeding two (2) hours without specifically obtaining authorization by the Chief of Police or his designee.

Section C. Winter Parking Ban

No vehicle shall be left standing or parked on any public way in the Town of Greenville, between the hours of 10 pm and 7 am from November 1st to April 1st.

Between April 1st and November 1st, the police department may authorize parking in the restricted zones on Main Street, as defined by Ordinance Number 92-02 "No Parking Zones", when the following is complied with:

1. Resident must call the department and give the make, color and license number;
2. Vehicle must be parked in front of the residence of the operator;
3. The same vehicle may not be parked for more than three consecutive days.

Anyone convicted of violating said ordinance shall be guilty of a violation. The Police Department may issue a PARKING VIOLATION NOTICE instead of taking court action, for those violation's which do not involve an accident. The cost of PARKING VIOLATIONS WILL BE \$15.00. Any person who fails to pay a PARKING VIOLATION within seven (7) days from the date of issue shall have the cost of the Parking Violation doubled and may be summonsed to court.
